transpacific antiracism introduces the dynamic process out of which social movements in black america japan and okinawa formed afro asian solidarities against the practice of white supremacy in the twentieth century yuichiro onishi argues that in the context of forging afro asian solidarities race emerged as a political category of struggle with a distinct moral quality and vitality this book explores the work of black intellectual activists of the first half of the twentieth century including hubert harrison and w e b du bois that took a pro japan stance to articulate the connection between local and global dimensions of antiracism turning to two places rarely seen as a part of the black experience japan and okinawa the book also presents the accounts of a group of japanese scholars shaping the black studies movement in post surrender japan and multiracial coalition building in u s occupied okinawa during the height of the vietnam war which brought together local activists peace activists and antiracist and antiwar gis together these cases of afro asian solidarity make known political discourses and projects that reworked the concept of race to become a wellspring of aspiration for a new society

the surprising alliance between japan and pro tokyo african americans during world war ii in november 1942 in east st louis illinois a group of african americans engaged in military drills were eagerly awaiting a japanese invasion of the u s an invasion that they planned to join since the rise of japan as a superpower less than a century earlier african americans across class and ideological lines had saluted the asian nation not least because they thought its very existence undermined the pervasive notion of white supremacy the list of supporters included booker t washington marcus garvey and particularly w e b du bois facing the rising sun tells the story of the widespread pro tokyo sentiment among african americans during world war ii arguing that the solidarity between the two groups was significantly corrosive to the u s war effort gerald horne demonstrates that black nationalists of various stripes were the vanguard of this trend including followers of garvey and the precursor of the nation of islam indeed many of them called themselves asiatic not african following world war ii japanese influenced afro asian solidarity did not die but rather foreshadowed dr martin luther king s tie to gandhi s india and black nationalists post 1970s fascination with maoist china and ho s vietnam based upon exhaustive research including the trial transcripts of the pro tokyo african americans who were tried during the war congressional archives and records of the negro press this book also provides essential background for what many analysts consider the coming asian century an insightful glimpse into the black nationalists struggle for global leverage and new allies facing the rising sun provides a complex holistic perspective on a painful period in african american history and a unique glimpse into the meaning of the enemy of my enemy is my friend

why do some groups retain their ethnicity as they become assimilated into mainstream american life while others do not this study employs both historical sources and contemporary survey data to explain the seeming paradox of why japanese americans have maintained high levels of ethnic community involvement while becoming structurally assimilated most traditional approaches to the study of ethnicity in the united states are based on the european immigrant experience and conclude that a zero sum relationship exists between assimilation and retention of ethnicity community solidarity weakens as structural assimilation grows stronger japanese americans however like american jews do not fit this pattern the basic thesis of this book is that the maintenance of ethnic community solidarity the process of assimilation and the reactions of an ethnic group to outside forces must be understood in light of the internal social organization of the ethnic group which can be traced to core cultural orientations that predate immigration though frequently excluded from mainstream economic opportunities japanese americans were able to form quasi kin relationships of trust upon which enduring group economic relations could be based the resultant ethnic economy and petit bourgeois family experience fostered the values of hard work deferred gratification and other perspectives conductive to success in mainstream society this book will be of interest to sociologist and psychologist studying ethnicity community organization and intergenerational change and to anyone interested in the japanese american experience from an economic or political perspective asian american studies or social history of the united states

popular conceptions hold that capitalism is driven almost entirely by the pursuit of profit and self interest challenging that assumption this major new study of american business associations shows how market and non market relations are actually profoundly entwined at the heart of capitalism in solidarity in strategy lyn spillman draws on rich documentary archives and a comprehensive data set of more than four thousand trade associations from diverse and obscure corners of commercial life to reveal a busy and often surprising arena of american economic activity from the intelligent transportation society to the american gem trade association spillman explains how business associations are more collegial than cutthroat and how they make capitalist action meaningful not only by developing shared ideas about collective interests but also by articulating a disinterested solidarity that transcends those interests deeply grounded in both economic and cultural sociology solidarity in strategy provides rich lively and often surprising insights into the world of business and leads us to question some of our most fundamental assumptions about economic life and how cultural context influences economic

in the first book to focus on african american attitudes toward japan and china marc gallicchio examines the rise and fall of black internationalism in the first half of the twentieth century this daring new approach to world politics failed in its effort to seek solidarity with the two asian countries but it succeeded in rallying black americans

in the struggle for civil rights black internationalism emphasized the role of race or color in world politics and linked the domestic struggle of african americans with the freedom struggle of emerging nations of color such as india and much of africa in the early twentieth century black internationalists including w e b du bois and marcus garvey embraced japan as a potential champion of the darker races despite japan s imperialism in china after pearl harbor black internationalists reversed their position and identified nationalist china as an ally in the war against racism in the end black internationalism was unsuccessful as an interpretation of international affairs the failed quest for alliances with japan and china gallicchio argues foreshadowed the difficulty black americans would encounter in seeking redress for american racism in the international arena

since 1855 nearly half a million japanese immigrants have settled in the united states and today more than twice that number claim japanese ancestry while these immigrants worked hard established networks and repeatedly distinguished themselves as entrepreneurs they also encountered harsh discrimination nowhere was this more evident than on the west coast during world war ii when virtually the entire population of japanese americans was forced into internment camps solely on the basis of ethnicity

the author argues that african americans can reject a biological idea of race and agree with many criticisms of identity politics yet still view black political solidarity as a needed emancipatory tool african american studies

the redress movement refers to efforts to obtain the restitution of civil rights an apology and or monetary compensation from the u s government during the six decades that followed the world war ii mass removal and confinement of japanese americans early campaigns emphasized the violation of constitutional rights lost property and the repeal of anti japanese legislation 1960s activists linked the wartime detention camps to contemporary racist and colonial policies in the late 1970s three organizations pursued redress in court and in congress culminating in the passage of the civil liberties act of 1988 providing a national apology and individual payments of 20 000 to surviving detainees

offering a window into a critical era in japanese american life pacific citizens collects key writings of larry s tajiri a multitalented journalist essayist and popular culture maven he and his wife guyo who worked by his side became leading figures in nisei political life as the central purveyors of news for and about japanese americans during world war ii both those confined in government camps and others outside the tajiris made the community newspaper the pacific citizen a forum for liberal and progressive views on politics civil rights and democracy insightfully addressing issues of assimilation multiracialism and u s foreign relations through his editorship of the pacific citizen as well as in articles and columns in outside media larry tajiri became the japanese american community s most visible spokesperson articulating a broad vision of nisei identity to a varied audience in this thoughtfully framed and annotated volume greg robinson interprets and examines the contributions of the tajiris through a selection of writings columns editorials and correspondence from before during and after the war pacific citizens contextualizes the tajiris output providing a telling portrait of these two dedicated journalists and serving as a reminder of the public value of the ethnic community press

this book presents theoretical examinations of why and how connecting people yields different results from those of the market mechanism alone with an ever greater disparity between the world s rich and poor actions have been taken to remove the imperfections and remedy malfunctions of the market mechanism an underlying theme of these activities is to connect people and make them directly visible to one another thus the integrating concept of the solidarity economy emerges this volume analyzes diverse examples and practices of solidarity economy adam smith emphasized the importance of sympathy among people and the role of the impartial spectator in order to control otherwise reckless markets these major concepts form the basis of a solidarity economy the examples and practices in this book are based on this framework the first is the idea of social business promoted by prof m yunus of the grameen bank although the group of five members in the grameen bank organization is considered a system of mutual surveillance by some economists it is not a system based on distrust but a mechanism for mutual help and encouragement also examined in this book is organic agriculture which adheres to the necessity of face to face relationships it pursues environmental concerns and food safety by bringing together consumers and producers in local areas and by sharing knowledge when consumers and producers are widely separated a system of certification assures consumers that no chemical pesticides and fertilizers are used connecting consumers and producers through certification systems can be seen as part of fair trade mechanisms these mechanisms are applied in certified coffee programs for instance to reduce poverty to protect the environment and to safeguard human rights this book proposes that all these seemingly different types of activities can be understood as part of the solidarity economy with this unifying theme the book will be useful for both theoretical investigations and practical applications

award winning author edward s miller contends in this new work that the united states forced japan into international bankruptcy to deter its aggression while researching newly declassified records of the treasury and federal reserve miller a retired chief financial executive of a fortune 500 resources corporation uncovered just how much money mattered washington experts confidently predicted that the war in china would bankrupt japan not knowing that the japanese government had a huge cache of dollars fraudulently hidden in new york once discovered japan scrambled to extract the money but miller explains in july 1941 president roosevelt invoked a long forgotten clause of the trading with the enemy act of 1917 to freeze japan s dollars and forbade it to sell its hoard of gold to the u s treasury the only open gold market after 1939 roosevelt s temporary gambit to bring japan to its senses not its knees was thwarted however by opportunistic bureaucrats dean acheson his handpicked administrator slyly maneuvered to deny japan the dollars needed to buy oil and other resources for war and for economic survival miller s lucid writing and thorough understanding of the complexities of international finance enable readers unfamiliar with financial concepts and terminology to grasp his explanation of the impact of u s economic policies on japan his review of thirty seven studies of japan s resource deficiencies begs the question of why no u s agency calculated the impact of the freeze on japan s overall economy his analysis of a massive oss state department study of prewar japan clearly demonstrates that the deprivations facing the japanese people were the country to remain in financial limbo buttressed its choice of war at pearl harbor such a well documented study is certain to be recognized for its significant contributions to the historiography of the origins of the pacific war

the japan of pure invention not only sheds new light on a seemingly familiar sold chestnut it raises new possibilities for understanding the endurance of orientalism in relation to both whiteness and blackness karen shimakawa author of national abjection the asian american body onstage
